# To consider and approve the appointment and remuneration of the Company's auditors for the year ending 31 March 2016

The meeting of the Audit Committee (No.2/2558) held on 2 June 2015 expressed its satisfaction on the performance and efforts of Karin Audit Company Limited for the fiscal year ended 31 March 2015 and recommended the Board of Directors to appoint the said firm as the auditor of the Company for another term with a total fee for the year ending 31 March 2016 in the amount of Baht 5,780,000 (2015 – Baht 5,330,000).
